THE 2027 BREEDERS' STAKES PROGRAM
(YEARLING NOMINATIONS)

Upon payment of the appropriate nomination fee in accordance with the nomination schedule below, all **Yearlings of 2027** which were foaled in Barbados, will be eligible to run in any of the following Breeders' Stakes races for which the horse qualifies either by age, sex or points according to the following schedule. (Further nomination payments may be required for each individual race.)

1. A race for two-year-old horses over 1,100 metres, to be run during the Third Season of racing, 2028.
2. A race for three-year-old horses over 1,570 metres, to be run during the First Season of racing, 2029.
3. A race for three-year-old and older horses over 1,100 metres, to be run during the 2029 Racing Calendar, and in such subsequent years as may be determined by the Barbados Thoroughbred Breeders' Association and The Barbados Turf Club.
4. A race for three-year-old and older horses over 1,800 metres, to be run during the Third Season of racing, 2029; and in such subsequent years as may be determined by the Barbados Thoroughbred Breeders' Association and The Barbados Turf Club.

Please see the list of **2026 Breeders' Stakes Stallions** and their returns to identify which yearlings are eligible for nomination without penalty.

NOMINATION SCHEDULE

For a horse sired by a BTBA-nominated stallion –

Foal Nomination Deadline -
\$300 by Friday 30th October, 2026

Primary Yearling Nomination Deadline -
\$300 by Friday 30th July, 2027

1st Chance Yearling Nomination Deadline (if Foal deadline is missed) -
\$900 by Friday 30th July, 2027

Last Chance Yearling Nomination Deadline (if Primary deadline is missed) -
\$1,000 by Friday 19th November, 2027

Two-Year-Old Nomination Deadline (if all previous deadlines are missed) -
\$3,000 by Friday 14th January, 2028

If Foal is paid for and by the Yearling stage you lose it (**Please inform the BTBA in writing**) 50% of the nomination shall be placed towards your next Foal registration.

For a horse sired by a non-BTBA-nominated stallion –

Foal Nomination Deadline –
\$1,250 by Friday 30th October, 2026

Primary Yearling Nomination Deadline –
\$2,500 by Friday 30th July, 2027

Secondary Yearling Nomination Deadline (if Primary deadline is missed) -
\$3,000 by Friday 19th November, 2027

Last Chance Yearling Nomination Deadline (if all previous deadlines are missed) -
\$4,000 by Friday 10th December, 2027

Two-Year-Old Nomination Deadline (if all previous deadlines are missed) -
\$5,000 by Friday 14th January, 2028

Note 1 (For horses sired by non-BTBA-Nominated stallions)

The horse to be nominated and its dam must remain domiciled in Barbados for a period of at least eighteen (18) months after the foaling date.

- a. This condition can be waived only via death of the dam while in Barbados OR,
- b. If the said broodmare or dam of the horse to be nominated is certified by a veterinarian as pregnant for a locally-based stallion prior to being exported from Barbados, provided the horse to be nominated remains domiciled in Barbados for the stipulated eighteen-month period.

All applicable fees must be received by the Barbados Thoroughbred Breeders' Association on or before 4:00p.m. on their respective deadlines at the Registered Office of the Barbados Turf Club, The Garrison, St. Michael.

Payments made by cheque and delivered through the post, or howsoever else made must be posted or delivered so as to be received at the Registered Office aforesaid by or before 4.00pm on the due dates, and unless received by such time **will not** be accepted.

The schedule for the races to be run, and all conditions herein stipulated are subject to the clause that if due to financial or other unforeseen circumstances all or any of the races cannot be staged (or a specific condition met), then any other schedule or condition or determination will be at the sole discretion of the Barbados Thoroughbred Breeders' Association without any liability whatsoever to the Barbados Turf Club or the Barbados Thoroughbred Breeders' Association. Adequate notice will be provided in the event of such changes.

For each of the races above, there will be an Entry fee of 2.5% of the first prize payable on the day appointed for the taking of General Entries. **NOMINATIONS AND PENALTIES ARE NON-REFUNDABLE. Entry fees only will be refunded to any horse eliminated from a race.**

PURSE / VALUE OF RACES

The purse for each of the aforementioned Breeders' Stakes Races is projected to be the total amount of prescribed nominations received for the respective race plus 50% of all penalties received for the respective race, plus such amounts as may be added by the Barbados Turf Club and a Sponsor (less 15% deducted for administrative costs).

BTBA FINANCIAL MEMBERS AT THE TIME WHEN PAYMENT IS DUE WILL BE ENTITLED TO 5% DISCOUNT.
